

Private and Secure


Executing HIPAA compliant security protocols as well as eliminating unnecessary paper copies of sensitive data which could be lost, forgotten or misused.


Patient sees health-related events





Online appointment use cases

- Remote surgery consultation pre- and post-op surgical consultations, monitoring of wound healing
- Remote physiotherapy/rehabilitation demonstration how to perform exercises, check in to assess progress
- Remote nursing monitor basic health level, help with simple and urgent cases, routine pre-hospitalization and post-hospitalization care







Patient receives prescribed medicine

Patient automatically receives a scheduled event to buy prescribed medication when it is prescribed by a doctor.

Patient has all needed information in the event description, including the barcode that needed to be shown in a pharmacy.

Description

180 mcg (2 puffs) every 4 to 6 hours as needed. Do not exceed 12 puffs/day. At severe episodes: 4 to 8 puffs every 20 minutes for up to 4 hours, then 4 to 8 puffs every 1 to 4 hours as needed.

Prescription expiration reminders

Patient will see how many days left to go to a pharmacy before the prescription expired.

Pharmacy processes e-prescription

Doctor prescribes medicine and puts an order to a pharmacy. Pharmacy automatically receives a task to prepare a prescribed medication (note: pharmacy flow is out of scope).

Both the patient and the doctor see the e-prescription order progress and information about the delivery status in the event details.

Prescription order status

Doctor can see the actual status of the prescription, e.g. Processing, Out for delivery, Completed, Cancelled.
